
## Invitation for Bids



4. Interested Bidders shall submit to electronic Bids through [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) to the office on or before **12:00 noon 2075/08/06**.
5. Bids shall be opened in presence of Bidders' representatives who choose to attend on **14:00 pm, 2075/08/06** at the office. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum as mentioned below which shall be valid for minimum **30 days** beyond the bid validity period. Bidders shall deposit the bid security at the above bank mentioned or as bank guarantee in standard format as specified in bidding document from 'A' class commercial bank specifying the contract.
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
8. Pre-bid meeting shall be held at Ministry of Industry, Tourism, Forest and Environment, Surkhet at 2075/07/28, 12:00 Noon.
9. Bids should comply in all respects with the instruction to bidder include in the bid document. Non compliance with this instruction shall result in disqualification.
10. The bidder must submit the original copy of their e-bids within 7 days of bid submission.
11. Matters not covered by this notice shall be in accordance with public procurement act, 2063 and public procurement regulation 2064, and other prevailing rules and regulations.
